On the Monday and Tuesday following the ASCLD Symposium in Scottsdale, the National Commission on Forensic Science held their second meeting in Washington, DC. During the first day of the meeting, the Commission heard presentations on cognitive bias and ethics in forensic science. The second day was reserved for a report from each of the subcommittees and an update from NIST on the OSAC applications.
