Dear Colleagues,

This past Friday, June 5th, we had our first ASCLD Board Teleconference. Our Board did a final review of the 2015 ASCLD Symposium and we are happy to share with you that our final profit after all expenses for the symposium was over \$51,000. Additionally, the Board approved a multi-year contract with Kinsley Meetings to continue working with them on symposium planning for the next three years. President Elect Jeremy Triplett is already in the initial planning stages for the 2016 symposium which will be in Bellevue, Washington.

The Vendor Committee has also been successful in working with our vendors to solidify their commitment for the 2016 symposium. This is an incredibly important aspect of our symposium planning process as this is a significant revenue stream for ASCLD and I'm excited to share we are ahead of the game with several early commitments for next year's symposium.

Our remaining committees are also hard at work preparing for this next year. The Membership and Ethics/Bylaws Committees are working to bring you a bylaws change proposal for the 3-2-1 requirement to run for the Board as explained during the 2015 Business meeting and in previous editions of the Crime Lab Minute. These will be scheduled as soon as all presenters and resources are confirmed. Additional webinars will be hosted throughout the year on topics relevant to our membership and community along with the ASCLD Leadership Academy.

As you can see, the ASCLD Board has hit the ground running for 2015-2016 year and we are very excited to continue to bring you information and resources in support of ASCLD's mission of "excellence through leadership in forensic science management."

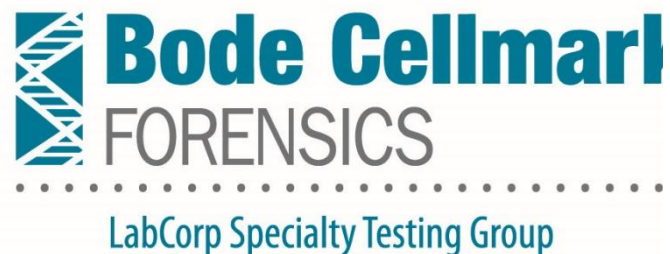
