ASCLD Board Comments

Views Document on "Establishing the Foundational Literature within the Forensic Science Disciplines"

The ASCLD Board of directors supports the view of the NCFS on **Establishing the Foundational Literature within the Forensic Science Disciplines"** and requests that it be made a Directive Recommendation to the Attorney General and incorporates the following recommendations.

- 1. "The NCFS recommends that the Attorney General task NIJ with a comprehensive literature review in forensic science using the criteria put forward in this document. It is further recommended that NIJ be tasked with partnering with groups such as national crime lab leadership organizations, national and regional forensic organizations, researchers, and other experts with technical expertise to evaluate each article using a defined value rating criteria or matrix."
- 2. "The NCFS recommends that the Attorney General provide funding and direction to NIJ to provide an access portal to scientific research for public federal, state, and local FSSPs and FSMPs. This could be accomplished by treating public FSSPs and FSMPs as a small university for access into journals through a commercially available licensing agreement or through some other means identified by NIJ."
- 3. "The NCFS recommends that the Attorney General requests more funding in the DOJ budget request for NIJ to accomplish basic and applied forensic science research."

ASCLD is dedicated to the advancement of forensic science and the path forward must include efforts and resources for foundational research and investigation. Additionally, it is critical this information is continually made available to all practitioners and organizations responsible for the practice of forensic science at no cost to ensure the information is being disseminated across the community.
