President Message

The American Society of Crime Laboratory Directors (ASCLD) is requesting proposals (RFP) for a contractor to provide a firm fixed price solution to transfer data from forensic Laboratory Information Management Systems (LIMS) to FORESIGHT, a business quantitative process tailored to forensic laboratories. The goal of the project, called FORESIGHT 20/20, will be to allow laboratories to easily upload business-relevant information from their individual LIMS to the FORESIGHT project, hosted at West Virginia University; additional information on FORESIGHT can be found at: www.be.wvu.edu/forensic/foresight.htm. FORESIGHT, in turn, will provide tailored quantitative reports and evaluations to the laboratories about their performance. In short, this RFQ seeks coding that connects the LIMS to FORESIGHT to benchmark forensic laboratory performance. Applicants must be a junior or senior in a baccalaureate program or a graduate student (masters or doctorate) at an accredited university who is pursuing a degree in forensic science, forensic chemistry, a physical or natural science. High school students or college/university students in their freshman or sophomore years will not be eligible for application. As the scholarship program was created to provide opportunity to students intending to enter the forensic field, scholarships will not be granted to current forensic science laboratory employees pursuing graduate degrees.

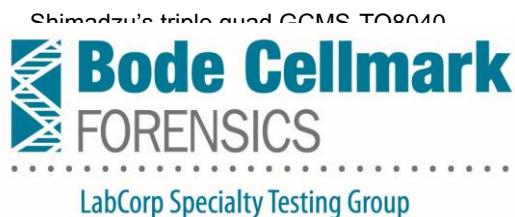
