ASCLD Board Comments

Recommendation of the Commission: Accreditation of Digital and Multimedia Evidence FSSPs

The American Society of Crime Laboratory Directors has a very long and historic record regarding accreditation from the development of the first crime laboratory accreditation program in the history of the United States in the 1980's. The program later became the American Society of Crime Laboratory Directors – Laboratory Accreditation Board (ASCLD/LAB). This organization became an independent accrediting body and a recognized industry leader in the accreditation of forensic science service providers (FSSPs) to international standards such as ISO/IEC 17025 and 17020. ASCLD has continued to publicly promote the need for universal accreditation of all forensic science service providers including digital multimedia providers.¹

The ASCLD Board of Directors adamantly supports accreditation of FSSPs and applauds the NCFS for providing this recommendation to the Attorney General. In support of these recommendations, the Board requests the inclusion of these changes and consideration of our comments.

- Would the NCFS request a status update of the BJA census of FSSPs in the US? This
 information is invaluable to the community and can provide a better picture when it
 comes to understanding the service demand of the U.S. criminal justice system and the
 means through which this demand is met. Additionally, it can inform decision makers
 regarding funding in support of these efforts especially when it comes to requesting
 support for federal programs that can fund accreditation activities.
- 2. ASCLD is a member of the International Forensic Strategic Alliance (IFSA) which is a multilateral partnership between regional networks of operational forensic laboratories across the globe who work strategically with the United Nations Office of Drug Control and Interpol.² Their vision is to create opportunities for strategic collaboration across the global forensic science community. IFSA has developed Minimum Requirements Documents (MRDs) to assist FSSPs who are seeking accreditation. They were originally

developed for emerging FSSPs in developing countries, but the quality and technical framework needed to seek accreditation is the same regardless of language, border, or economic development. Three MRDs have already been developed and three more are currently in draft including a document specifically for digital multimedia evidence.³ ASCLD encourages that IFSA's MRDsbe incorporated into the future efforts of the DOJ and the Attorney General in assisting FSSPs to build the framework for a successful accreditation process.

3. The recommendation regarding the appointment of a group to determine best standards and supplemental requirements for accreditation of DME FSSPs seems redundant to other efforts currently underway including the Digital Subcommittee of the Organization of Scientific Area Committees (OSAC) and the ISO Technical Committee (TC) 272 – Forensic Sciences. ASCLD requests that the recommendation be revised to point to these efforts and support of the OSAC and ISO TC272 work products to guide the DME FSSPs.
