President Message

ASCLD Invited to Attend the Grand Opening of Dubai PD's new \$100 million forensic facility

Colleagues,

Last week I was invited to represent ASCLD at the Grand Opening ceremony of the new Dubai Police Department Forensic Laboratory and training center. In recent years, Dubai PD has been active in developing international partnerships to improve their forensic services and ASCLD is proud to be one of those partners. Invited international partners who were in attendance were Catherine Knutson with ASCLD/LAB, Dr. Jose Almirall from Florida International University, Dr. Michael Wysocki from the University of Central Lancashire, Dr. Chung Hee Sun with the International Association of Forensic Toxicologists, and myself.

The Dubai PD laboratory is a beautiful, sprawling, Leed Gold facility which incorporates the traditional elements of a forensic laboratory, a dedicated research division, and a separate training institute that Dubai hopes to use to host and train forensic scientists in the Gulf States region. The laboratory boasts state-of-the-art laboratories and had carefully planned to allow for expansion of personnel and services in the future. In its training facility, the laboratory houses equally equipped training labs and an electronic journal subscription service that provides free access to millions of journal articles at a trainee's fingertips. It is truly a remarkable building.

Dubai PD is an ardent supporter of ASCLD and greatly values our assistance and expertise as they improve forensic services in their region. Two Dubai PD lab managers are ASCLD members and two additional supervisors are currently enrolled in the 2016 ASCLD Leadership Academy. During my stay, I had many productive conversations with laboratory management that I hope lead to enhanced future collaboration, with both ASCLD and our IFSA partners. I would like to thank the Dubai Police Department for their gracious hospitality and the opportunity to visit their laboratory. I believe that the future of collaboration between ASCLD, Dubai PD, and the Persian Gulf States is extremely promising.

3-2-1 Bylaws proposal language:

SECTION 2. ELIGIBILITY & COMPOSITION

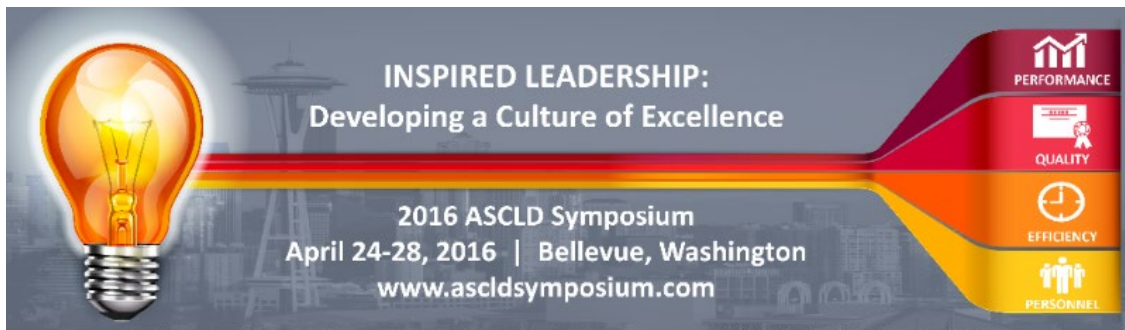
Eligibility for nomination and election to the Board of Directors includes the following three requirements:

- ASCLD Regular Membership for 3 years
- Attendance at two ASCLD Symposia as a Regular Member
- Volunteer service on one committee or at one event.

The Board of Directors shall consist of twelve (12) regular Directors, elected from the regular members of the Corporation. In addition, there shall be, two (2) non-voting ex-officio Directors, one (1) who shall be the

Executive Director of the Corporation and one (1) who shall be the immediate past President of the Corporation. If the immediate past President of the Corporation has not completed their full four year term of service on the board at the completion of their term as President, they shall retain their voting rights for their full four year term. No two regular Directors of the Board of Directors shall be from the same business, corporation or agency.

The membership will vote on this proposed bylaw change at the upcoming symposium in Bellevue, WA.
