I have been a forensic scientist for 24 years which includes 8.5 years as Toxicologist with the Florida Department of Law Enforcement Crime Laboratory, 13 years Manager of Chemistry and/or Toxicology Unit (13 years Toxicology, 10 Chemistry), and 3 years as Crime Laboratory Director.

I have been a member of the OSAC Toxicology Subcommittee since OSAC was created and have been the Toxicology Subcommittee Vice-Chair for the past year. I have also been a member of the Academy Standards Board (ASB) Toxicology Consensus Body since the creation of the ASB.

I was board certified in forensic toxicology by the Forensic Toxicology Certification Board (FTCB) in 2003, a certification I held until August 2014, when the FTCB merged with the American Board of Forensic Toxicologists (ABFT). I have been board certified in Forensic Toxicology by ABFT since 2008, and board certified by the American Board of Criminalistics in Drug Analysis since 2010.

I have been on the Board of Directors for the Society of Forensic Toxicologists (SOFT) since 2018, and I am currently the Treasurer. I am also a Fellow of the American Academy of Forensic Sciences.
